- 1. Mr. S. M. Bhat (DIN:05168265), resigned from the office of / position of the Managing Director/ Employee/ Director of the Company on and with effect from 7th September 2020. The Board of Directors accepted his resignation with immediate effect and relieved him from his duties as the Managing Director.
- 2. Mr. Aditya T. Malkani (DIN:01585637), Non-Executive & Non-Independent Director of the Company, based on the recommendation of the Nomination & Remuneration Committee(NRC), has been appointed as the Managing Director of the Company with effect from Monday, 14th September 2020 for a period of three(3) years i.e. till 13th September 2023 by the Board of Directors of the Company, subject to the terms & conditions, to be recommended by the Nomination & Remuneration Committee(NRC), and subject to the approval of the shareholders to be taken at the 68 "Annual General Meeting (AGM)".
- 3. Mr. Girish Anant Patkar, Chief Financial Officer & Key Managerial Personnel was assigned a different role / responsibility in the Organisation with effect from 9th September 2020. In view of the above, Mr. Girish Anant Patkar will no longer be in the role of the Chief Financial Officer (CFO) and Mr. Suryakant Sethia, Deputy General Manager (Finance & Accounts) will be the Interim Chief Financial Officer (CFO) of the Company from 09th September, 2020
- 4. Ms. Aruna B. Advani, (DIN 00029256) Executive Chairman, superannuated from the Board of the Company on 18th November, 2019, on attaining the age of 65. Pursuant to the succession planning at the Company, the Board, on recommendation of the Nomination and Remuneration Committee, re-designated Mrs. Ninotchka Malkani Nagpal (DIN: 00031985), Whole-Time Director, as the Executive Chairman w.e.f. 19th November, 2019, subject to the approval of the shareholders at the ensuing Annual General Meeting, considering her expertise in the area of Financial Management, her business foresight and her rich, long-term association with the Company for over 20 years.
- 5. The shareholding of J. B. Advani & Company Private Limited in 1908 E-Ventures Private Limited has changed from 57.01% to 33.26%.
