The Financial Results have been prepared in accordance with the Indian Accounting Standards ("the AS") 34 "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and SEBI Circular No. CIR/CFD/PAC/2020/16 dated July 5, 2016 as amended from time to time. The above financial results have been reviewed by the Audit Committee and subsequently approved and taken on record by the Board of Directors at its meeting held on August 11, 2020. The Limited Review for the quarter ended June 30, 2020 results as required under Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015, has been carried out by the Statutory Auditors.
 2. The figures for the quarter ended March 31, 2020 are the balancing figures between audited figures in respect of the full financial year and the published year to date figures upto December 31, 2019.
 3. The Other Comprehensive Income (OCI) in the Statement of Profit and Loss, includes unrealized gain on fair valuation of equity instruments amounting to ₹ 10.89 Crore (previous year loss ₹ 99.65 Crore).
 4. The figures of the previous period/year have been regrouped/reclassified wherever considered necessary.
 5. Impact of Covid-19 Pandemic
 On account of COVID-19 pandemic, the Government of India had imposed a complete nation-wide lockdown on March 24, 2020 leading to temporarily shut down of Company's manufacturing facilities and operations. Since then the Government of India progressively relaxed lockdown conditions and has allowed the industry to resume its operations in a phased manner. During the quarter, the Company has resumed its manufacturing operations partially. Since the lockdown was in force for a significant period of the quarter, the Company's operations and financial results for the quarter ended June 30, 2020 have been adversely impacted. The results therefore, are not comparable with those for the previous quarters. Further, the Company has made assessment of its liquidity position from the previous recoverability and carrying value of its assets and liabilities as on June 30, 2020. The Company has considered internal and external sources of information for making said assessment. On the basis of said assessment, the Company expects to recover the carrying amount of these assets and no material adjustment is included in the financial results. The impact of any events and developments occurring after the balance sheet date on the financial results for the quarter ended June 30, 2020 may differ from that expected at the time of preparing the financial results.
